## With Valley Philanthropists...

### WE ARE STRONGER

Harold Meissner began his Andersen career in 1936 in the hardware department but made his biggest mark in sales. He was a life-long supporter of Andersen and passionate about the company. In the mid 1950's, the company set up its first sales region, a 17-state area stretching from Florida to Kansas in which Andersen



felt there was promise in establishing a regionally base and directed sales force. He launched a training program for distributors and dealers, and by focusing on the needs of customers in the region. Harold went on to serve as nationwide sales manager, vice president of sales, and executive vice president of marketing before he became president of Andersen Corporation in 1981.

Harold's presidency was distinguished by unprecedented sales growth, the refinement of the Perma-Shield product line, and the introduction of High-Performance glass. "I retired in 1992 from the presidency and from the board of directors," he said. "My, how the company has changed since then. There are new approaches to distribution and sales. But one thing has remained constant. As Fred Andersen always said, only the rich can afford to buy poor windows. Andersen is still making the best windows aound." \*

Harold was quietly, but deeply, philanthropic. He gave much and often, and many times anonymously. Three of his favorite Valley organizations were the hospice at Lakeview Hospital in Stillwater, the Hudson YMCA, and Courage-Kenny St. Croix. In the spring of 2017 he left a \$7.5 million bequest to the St. Croix Valley Foundation to be held and invested for these three organizations. His gift will grow and will continue to support these three organizations that are so important to the communities they serve.

## WE ARE STRONGER...

### When Individuals and their Companies Work Together in Philanthropy

Tim and Kim Bartz, owners of Mold Craft, a custom mold maker of injection molds for plastic and metal parts in Willernie, MN, began iWarriors in 2010. Their dream was to provide iPads and peripherals for warriors wounded in Afghanistan and Iran. Their industry nationally has supported them by making gifts to the iWarriors Fund at the St. Croix Valley Foundation. The recent iPad recipients, most of whom suffer from traumatic brain injuries (TBI) and/or PTSD, receive both inpatient and outpatient treatment. Most of their physical wounds have now healed, their brains - not so much, due to repeated IED and mortar blasts.

*The iPads have been so beneficial in Traumatic Brain Injury (TBI) treatment for these guys with apps available to help with memory recall, brain games, as well as a calendar to help them with scheduling appointments and other events they have a hard time keeping track of, taking and refilling meds, etc. They are able to regain control of and live a more independent life, which takes the burden off of their caregivers, usually the spouse. For those with PTSD and especially those battling depression, receiving such a gift does wonders. They tell us rather than feeling isolated and alone, they believe they have not been forgotten but forever remain in the thankful hearts and minds of so many Americans who support them. Tim and I feel so fortunate to have met so many wonderful people within the plastics industry who have rallied around our cause to give back to these special men and women. ## BECOME A DONOR TYPES OF FUNDS TO SUIT YOUR CHARITABLE INTERESTS

There are various types of funds, distinguished by what they do and how granting decisions are made:

- **Vibrant Communities Fund** – A special endowment fund available for new and emerging needs throughout the Valley
- **The Community Dividend Fund** – Gifts given to SCVF or Affiliate Boards for their own grantmaking. (Grants decided by the SCVF or Affiliate Board)
- **Valley Impact Funds** – Funds established by a donor, SCVF or Affiliates in order to focus grants on a specific issue area, such as education or health or the environment. (Grants decided by the SCVF or Affiliate Board)
- **Family Foundation Advised Funds** – These funds are like having your own personal family foundation. Also known as Donor-Advised Funds, they are established by individuals, families or companies who want to recommend where grants are given (Grants recommended by the Donor)
- **Donor-Designated Funds** – Funds established by donors who want to focus their grants on specific nonprofits. (Grants are made automatically each year to the named nonprofits)
- **Agency Funds** – Funds established by nonprofit organizations, in which grants go back to them for their programs, capital or operating needs
- **Scholarships** – Funds established by donors. (Grants recommended by committees, which may include the donor, or may be given to the high school or institution of higher education)

# WE ARE STRONGER...

## *With the New Dementia-Friendly Communities Coalition for St. Croix County*

One way that the SCVF lives its mission – to enhance the quality of life in the St. Croix Valley – is through convening. Gathering individuals to address community concerns was the core objective of a unique pilot program that the SCVF launched in the fall of 2015 called The Remember Project. The Remember Project used one-act plays (made available through an organization called MemoryCare) to start community conversations around Dementia, reduce the fear and stigma around the disease, and make our communities more dementia friendly.

Through The Remember Project, 16 different communities hosted a total of 33 plays throughout the Lower St. Croix Valley. The project involved nine facilitators, a production company of 11, over 20 funders, and close to 1,000 attendees.

Today, the SCVF continues to be at the epicenter of this initiative as the organizer of the Dementia Friendly Communities Coalition (DFCC). The DFCC is comprised of close to 40 community members from Pierce, St. Croix and Polk counties, who are working to address caregiver support, education, and collaboration around this important topic.

## Competitive Grant Programs

SCVF provides donors with the opportunity to create new or add to existing Valley Impact Funds for causes that are closest to their hearts. The Foundation has funds addressing a variety of interests including the arts, music education, health and wellness, the environment, and animals. The advantage of these funds is their mission is unchanging yet they remain current and flexible. We cannot guess tomorrow's issues or know which organizations can best address those issues at that time. However, through our Valley Impact Funds and our competitive grants programs, the SCVF places grant dollars in the most capable hands at the right time, in perpetuity.

Since 2004, the SCVF has awarded close to \$800,000 to over 400 organizations through its competitive grants program.

In 2017 the St. Croix Valley Foundation awarded \$85,860 to 37 organizations located in Burnett, Pierce, Polk and St. Croix counties in Wisconsin and Chisago and Washington counties in Minnesota.

## Valley Impact through Health and Wellness Grants

Twelve organizations received a total of \$27,151 through the Health and Wellness Grant Program. The focus of this program is to address the challenge of childhood obesity by exploring the interactions between physical activity, healthy eating and the rich, natural resources the St. Croix region has to offer. Grants ranged from \$360 to \$4,893 and funded an array of projects from Luck School Harvest Garden to equipment for the Girl Scouts of Minnesota and Wisconsin River Valleys healthy living program at Girl Scout Camp Lakamaga in Marine on St. Croix.

The "Better Shelf for Better Health" grant provides the opportunity for a partnership between Somerset Community Food Pantry and PowerUp, a program of the Lakeview Foundation. PowerUp is a community-wide youth health initiative striving to make better eating and active living easy and fun, so that youth can reach their full potential. PowerUp will work with Somerset Community Food Pantry to redesign their food shelf to increase the quantity, visibility and appeal of healthy foods to clients.

The Somerset Community Food Pantry received a SCVF Health and Wellness grant for \$2,650 to continue their work with Lakeview Foundation to implement the Better Shelf for Better Health (BSFBH) program. This grant facilitated connections between local farms through the Farms Nourish our Community -- Providing Fresh Produce for Families in Need program.

## Valley Impact through Music Education Grants

Eleven schools received a total of \$32,199 through the Music Education Grant Program. These grants are intended to provide resources to sustain and enhance music programs in schools in the St. Croix Valley. This year, grants ranged from \$220 to \$5,000 to fund equipment and experiences, and most importantly, give the gift of music to thousands of children in the region.

Rocky Branch Elementary in River Falls, WI won a grant for \$220 to take 75 second grade students to a Young People's Concert performed by the St. Croix Valley Symphony Orchestra at University of Wisconsin-River Falls. The concert featured European Classics including works by Tchaikovsky, Beethoven, Brahms, and Bach. Prior to the event, the children participated in an Instrument Petting Zoo, which allowed them to have a hands-on-experience touching and playing the instruments.



Frederic Elementary School was the recipient of SCVF's Music Education Program. The \$500 grant supported drumming clinician, David Birrow, to visit Frederic Elementary School for a day-long 'junkyard' drumming workshop with K-6th grade students.

## Valley Impact through Valley Arts Grants

The Valley Arts Initiative Grant Program is supported by a grant from the Wisconsin Arts Board with funds from the State of Wisconsin and by the Hugh J. Andersen Foundation. This year, the SCVF awarded \$20,000 to eleven organizations. The funded projects draw audiences in the hundreds and even thousands to the Valley (Franconia Sculpture Park – 2015 Art & Artists Celebration, Music St. Croix – collaborating with Valley Chamber Chorale and St. Croix Jazz Orchestra to perform a free community concert, and The Phipps Center for the Arts – continues to deepen the "What We Need is Here Artist Seminar Series").

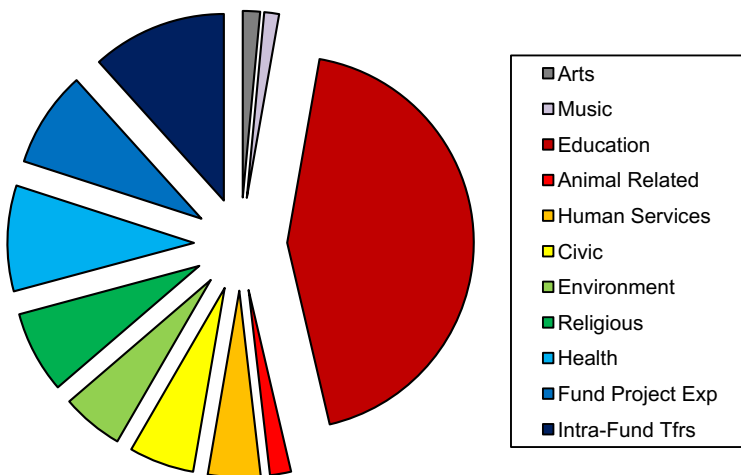

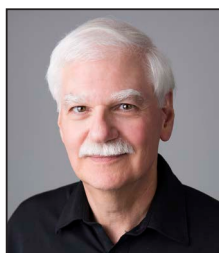

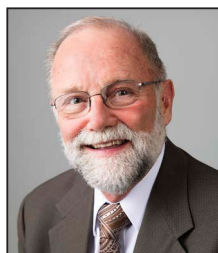
